INDEPENDENT AUDITOR'S REVIEW REPORT ON THE INTERIM CONDENSED CONSOLIDATED FINANCIAL STATEMENTS FOR THE SHAREHOLDERS AND SUPERVISORY BOARD OF BORYSZEW S.A.

Introduction

We have reviewed the accompanying interim condensed consolidated financial statements of the Boryszew Group, where the parent company is Boryszew S.A. with its registered office in Warsaw, at Al. Jerozolimskie 92, comprising the condensed consolidated statement of financial position prepared as at 30 June 2021, the condensed consolidated statement of comprehensive income for the period from 1 January 2021 to 30 June 2021, the condensed consolidated statement of changes in equity for the period from 1 January 2021 to 30 June 2021, the condensed consolidated statement of cash flows for the period from 1 January 2021 to 30 June 2021, and other explanatory information ("interim condensed consolidated financial statements").

The parent company's Management is responsible for the preparation and presentation of the interim condensed consolidated financial statements in accordance with the requirements of International Accounting Standards 34 Interim Financial Reporting, announced in the form of European Commission regulations.

Our responsibility is to form a conclusion on the interim condensed consolidated financial statements based on our review.

Scope of Review

We performed the review in accordance with National Standard on Review Engagements 2410 in the wording of International Standard on Review Engagements 2410 "Review of Interim Financial Information Performed by the Independent Auditor of the Entity", adopted in a resolution passed by the National Council of Certified Auditors.

A review of financial statements consists of making inquiries, primarily of persons responsible for financial and accounting matters, applying analytical and other review procedures.

A review is substantially less in scope than an audit conducted in accordance with National Standards on Auditing in the wording of International Standards on Auditing. In consequence, a review is not sufficient to obtain assurance that all significant matters that might be identified in an audit, have
